Guy H. Thorpe Memorial Scholarship

Century Federal Credit Union is currently accepting submissions for our Guy H. Thorpe Memorial Scholarship. This scholarship honors the legacy of Guy H. Thorpe, who served as a dedicated volunteer on the Century Federal Board of Directors for 30 years.

The award is a non-repayable, one time/non-renewable scholarship. Century Federal Credit Union is committed to assisting our youth club account members who choose to

further their education through post-secondary studies. Scholarships will be awarded to Century Federal Credit Union youth account members, per the eligibility requirements noted below.

- How to Apply: Download a PDF version of the Century Federal Guy H. Thorpe Memorial Scholarship application*
 form from www.CenFedCU.org or visit a branch to pick up an application.
- Eligibility: Century Federal youth club account members, of at least one year, who are high school seniors or recent high school graduates (no more than 6 months past graduation). Applicant must have earned a minimum of a 3.1 cumulative GPA on a 4.0 grade scale.
- Selection: Recipients of this award exhibit superior academic achievement and demonstrated community service
 throughout their high school careers. The Century Federal Scholarship Committee reviews all eligible applications
 and will select the scholarship recipients.
- Application Deadline: Applications must be received in a Century Federal branch or be mailed and postmarked by May 1, 2017. Applicants will receive email notification of application receipt. Award recipients will be notified no later than June 1, 2017.
