OFFICIAL RULES & ELIGIBILITY GUIDELINES

Scholarship Period: October 1–November 30, 2026

NO PURCHASE NECESSARY TO APPLY OR PARTICIPATE.

Participation is subject to all eligibility requirements and terms stated in these Official Rules.

1. Scholarship Overview

The Century Federal Credit Union ("Century FCU") Bank Boldly. Learn Fully. The Scholarship Program is designed to reward students who invest in their financial education as they prepare for their future educational goals.

Through Century FCU's partnership with Zogo, eligible applicants can complete financial literacy modules to earn entries into the scholarship drawing.

Century FCU will award:

- Two (2) Scholarships
- \$1,000 each
- Total Scholarship Funds Awarded: \$2,000

2. Scholarship Period

Applications Open: **October 1, 2026**

Application Deadline: **November 30, 2026**

Scholarship Recipients Announced: **December 2026**

Century FCU reserves the right to modify dates if necessary.

3. Eligibility Requirements

To be eligible for the Bank Boldly. Learn Fully. Scholarship Program, applicants must:

3.1 Membership Requirement

- Be a Century Federal Credit Union member in good standing for at least twelve (12) months prior to the application deadline.

3.2 Student Requirement

Applicants must be one of the following:

- High school senior

- Recent high school graduate
- Current college student
- Current technical or trade school student

3.3 Education Requirement

Applicants must plan to attend or currently attend an accredited:

- College
- University
- Trade school
- Vocational program

located within the United States.

3.4 Transcript Requirement

Applicants must submit:

- Current high school transcript; or
- Current college/trade school transcript

Unofficial transcripts are acceptable.

4. How to Participate

1. **Complete the application.** Complete the Century FCU Scholarship Application.
2. **Access Zogo.** Download or access the Zogo Financial Literacy App.
3. **Complete eligible modules.** Complete eligible financial literacy modules during the scholarship period.
4. **Submit documentation.** Submit all required scholarship documentation by the application deadline.

5. Scholarship Entry Levels

Applicants will receive scholarship entries based on verified Zogo module completion.

Modules Completed	Entries Earned
25 Modules	1 Entry
50 Modules	2 Entries
75 Modules	3 Entries

The maximum number of entries available is three (3).

Module completion will be verified through Zogo reporting provided to Century FCU.

6. Recommended Learning Paths

Students are encouraged to complete modules focused on:

- Budgeting
- Paying for College
- Student Loans
- Credit Scores
- Credit Cards
- Saving and Investing
- Financial Goal Setting
- Debt Management
- Building Emergency Savings
- Financial Wellness

7. Selection Process

At the close of the application period:

1. Century FCU will verify applicant eligibility.
2. Century FCU will verify Zogo module completion.
3. Eligible applicants will be assigned entries based on completed module tiers.
4. Two scholarship recipients will be selected through a random drawing from all eligible entries.

The more modules completed, the more entries earned and the greater the opportunity to be selected.

8. Scholarship Awards

Two recipients will each receive:

\$1,000 Scholarship Award

Scholarship funds may be issued:

- Directly to the student's educational institution; or
- Directly to the recipient if approved by Century FCU.

Scholarship funds are intended to support educational expenses, including:

- Tuition
- Books
- Fees
- Required educational materials

9. Recipient Notification

Selected recipients will be contacted using the email address and/or phone number provided on the scholarship application.

Applicants may be required to provide:

- Proof of enrollment
- Identification
- Additional documentation requested by Century FCU

Failure to respond within the timeframe provided may result in forfeiture of the scholarship award.

10. Publicity Release

By accepting a scholarship award, recipients grant Century FCU permission to use their:

- First name
- Photograph
- School name
- Scholarship story

for promotional and marketing purposes without additional compensation, unless prohibited by law.

11. General Conditions

Century FCU reserves the right to:

- Verify eligibility information
- Disqualify incomplete applications
- Disqualify applicants providing false information
- Modify, suspend, or terminate the scholarship program if circumstances require

All decisions made by Century FCU regarding eligibility, verification, and scholarship selection are final.

12. Privacy

Information collected through the scholarship application process will be used solely for:

- Scholarship administration
- Eligibility verification
- Winner notification
- Program reporting

Information will be handled in accordance with Century FCU's privacy practices.
